# DECLARATION OF DR. SONDRA S. CROSBY IN SUPPORT OF PETITIONER TARIQ BA ODAH'S MOTION FOR HABEAS RELIEF

I, DR. SONDRA S. CROSBY, pursuant to 28 U.S.C. § 1746, hereby declare as follows:

- 1. Among other appointments detailed below, I am currently the Director and Co-Founder of the Immigration and Refugee Health Program at the Boston Medical Center, Director of the Forensic Medical Evaluation Group at Boston University School of Medicine, Associate Professor of Medicine and Public Health at the Boston University Schools of Medicine and Public Health, in the Departments of Medicine, and Health Law, Bioethics, and Human Rights, and a member of the Section of General Internal Medicine at Boston Medical Center.
- 2. I have treated thousands of patients in clinical settings in twenty-five years of medical practice, have evaluated over 1,000 individual survivors of torture all over the world, and have examined numerous hunger strikers in Guantanamo, Connecticut, Kyrgystan and Bahrain. I have published scholarly articles in the New England Journal of Medicine and the

Journal of the American Medical Association on care and diagnosis of hunger strikers, and have been certified as an expert medical witness in the United States Immigration Court in Boston, Federal District Court for the District of Columbia, and the Military Commission Court in Guantanamo Bay, Cuba (United States v. Al-Nashiri).

- 3. I submit this declaration in support of the motion for habeas corpus relief by Tariq Ba Odah, an individual detained at Guantanamo, now in his 9th year of a hunger strike.
- 4. As I explain below, while I have information about some of Mr. Ba Odah's symptomology as communicated to me by his counsel, I do not have access to important medical records, let alone a history or physical exam, information that is essential to informing an accurate diagnosis about the variety of conditions and symptoms Mr. Ba Odah presents, or a precise prognosis about his prospects for recovery or survival.
- 5. Nevertheless, I am able to make certain diagnostic and prognostic assessments based on information the government has made available that Mr. Ba Odah weighs only 74.5 pounds approximately 56% of his normal body weight and has been at that weight for a period of months, and on reported symptoms from Mr. Ba Dah's counsel. I cannot overemphasize how alarming these facts are from a clinical perspective. Even without elementary diagnostic tests, I can confidently say that Mr. Ba Odah is suffering from severe malnutrition and that the continued course of presumed chronic caloric, protein and potential nutrient deficiency associated with such a state of starvation will, without medical intervention, lead inevitably to death, possibly in a period of months. It is also quite possible that he has already suffered injury to his organ functioning or gastro-intestinal (GI) system or that he is neuro-psychologically compromised in a manner that would need to be diagnosed and which I expect could require long-term treatment and rehabilitation.

- 6. There are limits to what the human body can endure, and at 74.5 pounds no matter the precise nature of his underlying medical complications Mr. Ba Odah is undoubtedly reaching those limits and may soon exceed them.
- 7. After setting forth my additional qualifications and basis for my opinion in this declaration, I (1) offer an assessment of the grave medical and neurological risks Mr. Ba Odah faces in his compromised and malnourished state, based on the information available to me; (2) explain the sophisticated medical interventions required to stabilize Mr. Ba Odah (i.e. prevent total organ failure and body collapse) and provide for full rehabilitation; and, (3) explain why, in my experience dealing with prisoners in a wide variety of custodial settings across the world, it should not be surprising that Mr. Ba Odah does not trust the sincerity or efficacy of the medical staff at the Guantanamo prison and why, under well-known medical ethical principles codified in the Malta protocol, Mr. Ba Odah should receive necessary medical care outside the present custodial setting.

# **Background and Qualifications**

- 8. I am a licensed physician in the Commonwealth of Massachusetts and am board certified in the specialty of Internal Medicine. I graduated from the University of Washington School of Medicine with my M.D. in 1991, and undertook my clinical training at the Boston City Hospital (now Boston Medical Center) residency program in Internal Medicine.
- 9. My clinical practice focuses on care of asylum seekers, asylees, and refugees, including hundreds of refugees from the Middle East. I have taught extensively on the medical care of refugees and cross-cultural medicine, and have published multiple scholarly articles on these topics. I have taught and mentored students on the evaluation of Istanbul Protocol compliance, and served as a medical consultant for Physicians for Human Rights in

Bishkek, Kyrgyzstan; Dushanbe, Tajikistan; Istanbul, Turkey; Reyhanli, Turkey; and Amman, Jordan.

- 10. I have evaluated and examined nearly 1,000 survivors of torture in my medical practice, and have worked with diverse populations who have experienced trauma. For example, I have evaluated Darfuri women living in a Refugee Camp in Chad, former detainees held in US detention at Guantanamo Bay, and patients at other sites in Iraq and Afghanistan. I have evaluated dozens of Syrians living in Turkey and Jordan who were displaced by civil war, and I have served as a medical forensic expert for the Bahrain Independent Commission of Inquiry, where I evaluated approximately 60 hunger strikers.
- 11. I am Director of the Forensic Medical Evaluation Group, a multidisciplinary group at Boston University School of Medicine and Boston Medical Center, providing evaluation and documentation of physical and psychological evidence of torture and abuse.
- 12. In my hospital practice I have also treated numerous persons who present with severe malnourishment either through late-stage disease or through severe anorexia nervosa.
  - 13. I am a Lt. Commander in the U.S. Navy Medical Corps.

# **Basis of My Opinion**

14. I obtained relevant information about Mr. Ba Odah from telephone conversations with his counsel, Mr. Omar Farah, and from reviewing a summary of Mr. Farah's notes regarding his observations, meetings, and correspondence with Mr. Ba Odah. I have not reviewed any metabolic or blood tests of Mr. Ba Odah, nor have I conducted a physical exam. Each of these would be important to come to a more precise conclusion about the severity of the conditions associated with his underlying malnutrition and to come to a prognosis about his likelihood of survival.

- 15. However, I understand the U.S. government has represented that, as of April 20, 2015, Mr. Ba Odah was 74.5 pounds, that this weight has been "stable" at that level since September 2014. According to the government 74.5 pounds constitutes 56% of Mr. Ba Odah's ideal body weight.
- 16. I also understand that Mr. Ba Odah's most recent labs were taken in February 2013 and that they included a full metabolic panel and blood count. According to the government, Mr. Ba Odah's results at that time were "normal."

# Mr. Ba Odah's Physical and Neurological Symptomology

- 17. While I must stress again that I cannot make a precise diagnosis or prognosis just on the basis of the information I have received from Mr. Farah and without the necessary tests and physical exam, I can state with confidence that many of the symptoms described are entirely consistent with severe malnutrition and the underlying caloric, protein, and micronutrient deficiency accompanying this serious condition.
- 18. According to counsel, during meetings, Mr. Ba Odah will go through what are described as "spells" during which Mr. Ba Odah becomes absent, appearing not to process what is happening around him. As it is described, Mr. Ba Odah will periodically also have a vacant look or affect. When he resumes alertness, he will require counsel to review or reexplain necessary information. This has become more pronounced in the last year.
- 19. Relatedly, I understand that one of Mr. Ba Odah's frequent complaints to counsel is that he cannot focus or concentrate. Mr. Ba Odah further complains that his memory is being compromised. According to his counsel, he has recounted experiences of forgetfulness. For example, he says he recently attempted to write a letter to his family but could not remember the current year.

- 20. Mr. Ba Odah has also described feelings of nervousness and agitation and the shivering of muscles and nerves. He describes a "Needles feeling in [his] heart."
- 21. He also describes numbness in his extremities and says he has to move his hands and feet "to resume circulation."
- 22. Mr. Ba Odah complains of back pain whenever he sits upright. He also describes that simply standing up creates the sensation of dizziness and his counsel observes that he is taken by bouts of extreme exhaustion. He reports that Mr. Ba Odah spends large parts of the day lying down in bed.
- 23. According to Mr. Ba Odah's counsel, during the one occasion he saw Mr. Ba Odah drink water, his hands shook noticeably as he raised the bottle such as one would expect of a very elderly, infirm person.
- 24. Of additional concern, Mr. Ba Odah complains of a range of symptoms that appear to be related to his gastro-intestinal track. Specifically, counsel reports that Mr. Ba Odah has complained of vomiting, blood in his stools, persistent constipation, and extremely raw, sore throat.

# Feelings Toward Medical Staff

- 25. Mr. Ba Odah has reported to counsel that JTF-GTMO has increased the amount of his feedings to respond to his weight-loss, but this sometimes causes him to vomit because he says his stomach can not tolerate the amount of food he is fed. I understand Mr. Ba Odah recently explained of his feeding that "what I used to get in two or three sessions, I now get in one."
- 26. He describes the base hospital as torture. He feels that the harsh treatment he has endured from guards has been done with involvement by doctors, who attempt to coerce

him. He reports that the doctors there do not treat him "in a civil way," and that their treatment of him is "all games."

27. Mr. Ba Odah reports that medical treatment at Guantanamo is intended only to convince him to abandon his strike, but that there is no genuine interest in treating his severe illnesses. Mr. Ba Odah also reports to his counsel that he believes medical staff have withheld appropriate medical care to influence him to stop his hunger strike.

## **Assessment and Conclusions**

- 28. On the basis of the limited information provided to me, especially his extremely low weight and accompanying symptoms, it is my medical opinion that Mr. Ba Odah is clearly suffering from severe malnutrition, a serious medical condition which presents a high risk of a host of dangerous medical complications, including death. Standard of care would dictate strict medical supervision in a hospital setting and frequent monitoring of organ function, including weights, vital signs, laboratory testing, and electrocardiogram, while providing nutritional support according to well-established protocols.
- 29. Mr. Ba Odah is 74.5 pounds and approximately half of his ideal body weight. Combined with his reported symptoms, this leaves no ambiguity about my concern for his health.
- 30. Given the severity of his current condition, moderate fluctuation in his weight would not alleviate my concern that he is at risk for serious medical complications. It is widely accepted that body weights below 70% of ideal body weight are considered medically dangerous because of increased risk of multiorgan dysfunction, life-threatening medical complications, and sudden death.

- 31. Specifically, the medical complications of chronic malnutrition are well described in the medical literature with which I am familiar from my own clinical experience treating patients with anorexia nervosa and other malnourished patients (hunger strikers, cancer, HIV, etc). These complications include hemodynamic instability (bradycardia, hypotension), arrhythmias (prolonged QT interval), volume depletion, metabolic alkalosis, liver inflammation, coagulopathy, bone marrow suppression, hypoglycemia, fall risk, gastroparesis and aspiration risk, cerebral atrophy and cognitive impairment, and osteoporosis. All organ systems can be affected by malnutrition, and damage can be irreversible. Death occurs by fatal heart arrhythmias, infection, or other organ failure.
- 32. Based on the information provided to me, Mr. Ba Odah is manifestly in a persistent state of decline, with expected diminished functioning. Mr. Ba Odah requires immediate medical evaluation and treatment. Clinical experience cautions that his continued malnutrition will begin to result in a dangerous spiraling effect.
- 33. In addition to his anticipated progressive malnutrition-driven decline, I must stress that in Mr. Ba Odah's precarious state, small insults such as injury, infection or fever can set off a fatal cascade of organ failure. His likely depleted organ functioning, diminished protein and fat stores, and vitamin deficiencies would make it extremely difficult for his body to respond to the stresses associated with commonplace infections in the way a healthy body would.
- 34. In addition, Mr. Ba Odah's symptomology, as described above, and his behavior as described by his counsel, can be explained by the known physical and neurocognitive derangements caused by malnutrition and described in the previous paragraph.

- 35. The reports of short-term memory loss and decreased concentration may be attributable to malnutrition, neurocognitive decline, vitamin deficiencies, depression, Post-Traumatic Stress Disorder, or other organic or psychological etiologies. It is likely multifactorial and requires extensive evaluation.
- 36. In my experience, psychiatric illnesses are also to be expected in patients experiencing indefinite detention and who present with the other neurological and physical symptomology Mr. Ba Odah says he is experiencing. As a clinical matter, I would recommend an appropriate evaluation as a precaution.
- 37. Any vomiting and hematemesis Mr. Ba Odah experiences may be due to gastroparesis as a result of his chronic malnutrition. Gastroparesis is well described in the anorexia nervosa literature and occurs when food does not empty normally from the stomach because the muscles in the stomach are not contracting properly. Gastroparesis can cause symptoms of gas, bloating, abdominal discomfort, nausea, vomiting, and heartburn, and can result in decreased ability to absorb nutrients. These symptoms require a comprehensive GI evaluation.

# **Required Medical Intervention**

- 38. Medical protocol for someone presenting at Mr. Ba Odah's body weight with his current symptoms would be immediate hospitalization. He would need to be stabilized and monitored while nutritionally repleted to reduce the risk of the potentially life-threatening complications described above.
- 39. Standard of care for a patient in this weight category would dictate strict medical supervision in a hospital setting, and frequent monitoring to include: weights, vital signs, laboratory testing, and electrocardiographic monitoring. Laboratory evaluation should

include complete blood count with differential, electrolytes including calcium, PTH, liver function, albumin, prealbumin, kidney function, RPR, TSH, vitamin levels (B12, folate, thiamine, Vitamin D, A, C), and a comprehensive neurological and psychiatric evaluation. Further testing would be dictated by initial results.

- 40. Arriving at a prognosis for Mr. Ba Odah's recovery is complicated by the largely unprecedented length of his hunger strike and my inability to perform a physical examination and appropriate diagnostic tests. I stress that without examining Mr. Ba Odah, I cannot know the nature and extent of any underlying impairments he may suffer from. However, given the length of his hunger strike, his reported symptoms, and very low body weight, it would not be surprising if he has suffered long-term damage to his GI tract, which can be irreversible. It is also certainly possible that he has suffered long-term neurocognitive impairment. He will likely require long-term rehabilitation for muscle reconditioning, including physical therapy.
- 41. After ensuring Mr. Ba Odah is out of imminent medical crisis, which will be a delicate, time and care-intensive process, there are standard protocols for sensitive reintroduction of micronutrients, protein and calories. That is not to be accomplished by merely reintroducing solid food into the diet. Complications inherent to the resumption of feeding ("refeeding syndrome), the hallmarks of which include life-threatening electrolyte disturbances (rapid depletion of phosphate, potassium, and magnesium) and heart failure due to volume shifts and a weakened heart muscle. Put simply, Mr. Ba Odah's survival and rehabilitation are out of his hands. He most likely cannot recover by simply abandoning his hunger strike and introducing solid food in his diet.

- 42. At the same time, Mr. Ba Odah reports that he maintains no trust in the medical staff at Guantanamo and at times does not assent to treatment that would be provided there. In my extensive experience working with individuals in detention settings across the world, this phenomenon of mistrust is widely observed and understood.
- 43. A trust-based doctor-patient relationship is of paramount importance for treatment and recovery. In penal environments, this relationship is commonly strained if physicians are viewed as part of the guard force. The bond of trust with prisoner patients may be irrevocably damaged if physicians have been involved in coercive behavior, such as force-feeding. Mr. Ba Odah believes not unreasonably in my opinion that physicians at Guantanamo have been utilized as instruments of the guard force to coerce prisoners to "break the strike." When this loss of trust occurs, patients will often not accept appropriate medical recommendations.
- 44. Because this is a widely observed and understood phenomenon, the medical profession has developed ethical standards to govern matters of patient mistrust of medical caregivers and the management of hunger strikers more broadly. The World Medical Association Declaration of Malta on Hunger Strikers, the authoritative source for medical ethical guidance as it relates to the treatment of hunger striking patients, instructs that when a doctor-patient relationship has been so compromised, the hunger-striking individual should be granted access to an outside independent physician of confidence.
- 45. In conclusion, based on the information I have been provided, it is my medical opinion that Mr. Ba Odah is seriously ill and at substantial risk for serious organ damage and/or death. His injuries may be permanent. It is my medical opinion that Mr. Ba Odah requires immediate medical evaluation and intervention to prevent further decline and

potential irreversible injury and eventual death. This treatment plan will require long-term monitoring, outpatient care and rehabilitation.

I declare under penalty of perjury, that the foregoing is true and correct.
